The Derby City Bop Association (DCBA) shall be a non-profit dance organization directed toward the entertainment and fellowship of the constituent members, and dedicated to the preservation of bop, shag, and swing style dancing exclusively, and the preservation of beach, bop, shag, and rhythm and blues music exclusively. The Derby City Bop Association may not dictate styles of dance, but will not, by it's music or instruction, support other forms of dance.

Membership in Derby City Bop Association is subject to the approval of the Derby City Bop Association Board of Directors and the General Membership present at the next regularly scheduled Board meeting held after receipt of this application. Board meetings are normally held the second Wednesday of each month, but are subject to scheduling by the club president. Upon approval, an Official DCBA membership card will be issued.

**Membership dues** are **\$35.00** per person per year. Membership in Derby City Bop Association is for a period beginning **January 1, and expiring December 31, each year.** Please make your check payable to Derby City Bop Association (DCBA). ## Release From Liability

Releasor agrees to indemnify the releasees and each of them from any loss, liability, damage or cost they may incur due to the presence of the releasor at any activity or function sponsored by the Derby City Bop Association, whether caused by the negligence of releasees or otherwise. Releasor hereby assumes full responsibility for the risk of bodily injury, death, or property damage due to the negligence of releasees or otherwise while for any purpose participating in any activity or function sponsored by the Derby City Bop Association. Releasor expressly agrees that this release, waiver and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of Kentucky and that if any portion hereof is held invalid, it is agreed that the balance shall notwithstanding continue in full legal force and effect.
